North West and Silvacom Announce Acquisition of Majority Interest in AltaLIS

Calgary, Alberta May 4, 2010

North West Geomatics Ltd. and The Silvacom Group™ today jointly announced their acquisition of QC Data's 65% ownership in AltaLIS Ltd. The acquisition results from several months of discussions and negotiations with QC Data, who were one of the founding shareholders of AltaLIS, along with Martin Newby Consulting (MNC) of Calgary. MNC will retain its 35% ownership of AltaLIS.

"We are proud and honoured to have completed this transaction, which we believe will significantly enhance the role and impact of AltaLIS within the geospatial community in Alberta." stated Tim Crago, Vice President of North West Geomatics. "Leveraging the solid reputation established by QC Data and MNC in operating AltaLIS over the past 13 years, we intend to expand upon the business and its role as the distributor of Alberta mapping data to all stakeholders in the Province".

"We consider ourselves fortunate to now be in a position to play a direct role in what has become an extremely successful partnership between the private sector and the Government of Alberta in making critical data and information available to all involved in land activities in the Province." added Tom Grabowski, President and CEO of Silvacom. "There are tremendous opportunities and challenges ahead of us and we are ready to deliver the required data and services as the Province moves forward in implementing new policies governing activities on the land".

AltaLIS, owned 65% by a jointly held North West/Silvacom company and 35% by MNC, will be announcing new and enhanced offerings in the future while continuing to provide essential services to the public and private sectors in Alberta.
